Course Title : Theories and Approaches of Comparative Politics

#### **Brief Course Description**

This course attempts a general survey in the field of comparative politics. Some important concepts and methods of the discipline are introduced. Specific topics include methods and approaches of comparative politics; government, regime and state; unitary, federal and confederal systems; typologies of state-society relations, specifically on bureaucratic-authoritarianism, totalitarianism, corporatism, civil society and populism; political culture and nationalism; interest group and political party; election and political participation; parliamentary, presidential and semi-presidential systems; comparative democracies between majoritarian and consociational model; and lastly on the topic of democratization and regime change.

#### <u>Aims</u>

This course surveys the leading theories and approaches within the field of comparative politics. Students will learn the relevant theories and approaches so that they will be able to connect their own research to broad disciplinary concerns. Students will be able to analyze political phenomena and events in a comparative manner if they put enough efforts in this course.

#### **Learning Outcomes (LOs)**

Students should be able to:

- 1. Critically evaluate alternative explanations and theories in the field of comparative politics and their applications to different national contexts.
- 2. Understand the strengths and weaknesses of these theories and their limitations in application.
- 3. Apply these learned methods, concepts, theories and approaches to understand the real world and to their own research.

## **Teaching Method**

Seminar approach with lectures, presentations and discussions mixed; with an expectancy of high interaction between students and instructor in a lively learning environment and resulted in a better learning outcome.

#### Assessment

#### Reading (10%):

- Students are required to read the weekly reading materials uploaded to Moodle (usually one long piece or two short pieces) before the class.
- Students will be randomly called up to share their understanding of the reading in every lecture

## Attendance and Participation (10%):

- Attendance is **COMPULSORY**
- Each absence counts 1% off the total 10%, except that the absence is reasoned before the class through email, with related evidence provided.
- However, students can make up their absence(s) by participation in the following formats:
  - Students' contributions to in-class debates and discussion
  - Contributions in classes include asking questions, sharing information and opinions, offering constructive analyses and criticisms
  - Informed discussion is based on everybody's regular reading and review of our covered topics.

#### Presentation (20%):

- A group of 7-8 students present on one topic to be listed on Moodle by **September 14**.
- 35-40 minutes presentation in the second half of the lecture starting from **October 5.**
- Each student should find their own partners and get ready for a 5-minute presentation.
- All groups should be formed by **September 21**.
- Post your presentation outline on **Moodle ONE day** before your presentation.
- Questions and discussion will follow the presentation.
- The grading is based on content, organization and effectiveness of the presentation as well as the afterwards leading of discussion by the presenters.

## Term paper (30%):

- Students are asked to write a group term paper based on their group presentation. The key is to develop a research question, analyze and discuss this question in a logical and clear manner, with appropriate footnoting and referencing.
- Each student is required to write at least **500 words** for the group paper.
- The term paper should be typed in a Word file in Times New Roman, font size 12, double space and around **3500-4000 words** in length (i.e., 3500 words for a 7-person group; 4000 words for a 8-person group). Students only need to submit a soft (PDF form) copy to **Moodle Turnitin** (one group submitting only one paper). The deadline of this term paper is **December 14, Saturday**. More details will be explained in class.
- Grading is mainly based on soundness of the research question, clear logic flow of the argument and convincing evidence provided. For more details, refer to the assessment rubric.

#### Final examination (30%):

- Closed book exam on **December 7**, **Saturday**.
- The final exam will be held in the lecture classroom and it tests students' overall understanding of related concepts and theories as well as empirical knowledge of different countries.
- The exam also tests whether students could apply their learned knowledge to understand the real world.
- If you need a special examination arrangement (only with justifiable reasons), please inform Dr. Wu earlier and seek for approval.
